



<u>Project Trunk</u>- existing Leavenworth business interested about 3 acres for expansion. Working with the business and city. (LCDC-direct)

<u>Project Harbor</u>- biopharma manufacturer looking for at least 100 acres of shovel ready land to build in three phases a 900,000 SF facility. Did not submit (KCADC-Emily).

<u>Project Heat</u>- client requested information on the Leavenworth Business & Tech Park and the Gary Carlson Business Park with interest in about five acres to building a 5,000 SF facility. Working with the LCPA on Lot 7 in the Gary Carlson Business Park. (LCDC-direct)

<u>Project Brady</u>- Commercial business interested in Basehor. Going through permitting phase and will apply for Spec Bldg loan program (LCDC-Lisa)



DISCUSSION:

During the June 21, 2022 Study Session, the Commission reviewed the existing Sign Recognition Policy and discussed potential changes to the program. The current Sign Recognition Policy, adopted in January 2017, provides means for recognizing local community members who have achieved notable accomplishments in their lifetime through the placement of a sign. Potential changes discussed during the June 21st Study Session centered around providing new recognition signage at a centralized location in Ray Miller Park, along with refined criteria for selection of honorees.

The draft update to the Sign Recognition Policy creates a consistent and streamlined nomination criteria, as well as provides for a specific means of placing signs in Ray Miller Park. It also accounts for handling of existing recognition signs. And the draft policy provides latitude for the City Commission to use discretion in reviewing nominees for inclusion on the recognition signs.

Local sign vendor, Young Signs, has worked with staff to create several conceptual designs for the new recognition signs. The concepts are a modern approach to celebrating the great achievements of Leavenworth locals. Recognition sign structures will be built as outlined in the draft policy and will include space for multiple honorees to be added at future dates.

Leavenworth Celebrates Sign Recognition Policy

DRAFT October 18, 2022

The City of Leavenworth is home to many individuals and groups with high levels of success and service. The City has established the following policy to evaluate honoring those community members that have attained the highest levels of achievement or that bring lasting renown to the City through a recognition sign. The selection of such qualifying achievements that should be included with long-term signage must be approved by the City Commission and should meet the following criteria:

- 1. The honoree (individual or group) should have been either born in Leavenworth, raised in Leavenworth (for example, graduated from a Leavenworth high school), or have had a longtime presence within the Leavenworth community. Priority will be given to individuals/groups who have achieved success on the international or national level and made contributions to the Leavenworth community throughout their lifetime. Other types of City recognition may be considered for worthy individuals/groups whose success has an important but shorter-term impact to the City's reputation, such as mayoral proclamations and temporary signage.
- 2. The highest levels of achievement or lasting renown to the City may result from success in various fields such as civic, academic, artistic/entertainment, athletic or the military. Other applicable service or distinctions may be approved by the City Commission.
- 3. Separate or additional signage is authorized for Sister/Brother City relationships and Medal of Honor recipients, as approved by the City Commission.
- 4. Leavenworth Celebrates recognition signs will be placed inside Ray Miller Park near the Veterans Affairs Hospital entrance area to encourage simplified viewing of all honorees and to allow City visitors access to additional honoree information through technology (ex. QR codes).
- 5. Honorees with City recognition signs in place before the establishment of the Leavenworth Celebrates Sign Recognition Policy will be included with new signage.
- 6. Honorees approved for inclusion in the Leavenworth Celebrates Sign Recognition Program may be presented with their recognition signs during a City Commission meeting or a separate ceremony when the sign is placed at Ray Miller Park, up to City Commission determination.
- 7. No specific time frame will be placed on the length of time that honorees are included in the Leavenworth Celebrates signage. If the signage must be removed or replaced due to damage, improper placement, or the need to update those honored, the City Commission can elect to do so without justification.
- 8. Signs will be commissioned by the City of Leavenworth following the standardized Leavenworth Celebrates design and created at the City's expense.
- 9. To request the placement of a recognition sign in the City of Leavenworth, a written request should be formally submitted to the City Clerk. The request shall include background information and justification on why a recognition sign is appropriate. City Commission approval for each honoree is required.





SIGN RECOGNITION POLICY Adopted January 10, 2017


The City of Leavenworth is committed to recognizing local community members who achieve great levels of success within their lifetime. The City of Leavenworth has established the following policy to evaluate the placement of signage on major thoroughfares within the City. All signage must be approved by the City Commission and the honoree's accomplishments should meet the following criteria:

- 1. The honoree should have either been born raised or have had a longtime presence within the Leavenworth community. Priority will be given to persons who have achieved success on the state or national level and made contributions to the local Leavenworth community throughout their lifetime. To be recognized, worthy individuals can achieve success in various fields; achievements in the civic, academic, artistic/entertainment, athletic or military background are all considered applicable. Other applicable service or distinctions may be approved by the City Commission on a case-by-case basis. Additional signage considered appropriate is the recognition of our Sister/Brother City relationship and Medal of Honor recipients.
- 2. The location for recognition signage within the City of Leavenworth shall be on the east side of 4th Street South of the V.A. entrance.
- No specific time frame will be placed on the length of time that a sign is erected. If a time comes
 when the signage needs to be removed because of damage, excessive use of signage or
 improper placement, the current City Commission can elect to do so without the need for
 justification.
- Signs will be commissioned by the City of Leavenworth and created at the City's expense if created in-house, otherwise at applicant's expense.
- 5. To request the placement of a recognition sign in the City of Leavenworth, the requesting individual or representative of the honoree should formally submit their request in writing to the City Commission and City Manager and submit the request to the Office of the City Clerk. Requests shall provide background and justification as to why a recognition sign is warranted.







LEAV HOMETOWN CONCEPT 5 - COMBINED PILLAR ROW








LEAV HOMETOWN CONCEPT 3 - COMBINED PILLARS






















LEAV HOMETOWN CONCEPT 1 - INDIVIDUAL FREESTANDING TRIBUTE INSTALLATIONS

ISSUE:

Review drafted Business Improvement and Expansion Grant (ARPA Pilot Program).

BACKGROUND:

The City currently has the Small Business Economic Development Grant that provides up to \$5,000 to Leavenworth businesses that make investments into retail and commercial buildings (up to \$15,000 for projects supporting two or more businesses). There are several eligible categories of expenses including fire suppression (sprinklers) and ADA accessible improvements.

The current level of the Small Business Economic Development Grant may not adequately address the high cost of certain improvements. Multiple businesses considering purchasing existing buildings, expanding into previously vacant space in their current building, and changing the use or occupancy level of their current space have expressed their concern with required fire suppression and interior ADA improvements. The City sets requirements based on 2018 International Existing Building Code (IEBC). Those requirements apply to "repair, alteration, addition, and change of occupancy" for existing and historic buildings that are different from the standards for newly constructed buildings. As a rule, businesses should balance the short-term cost for those updates with their ability to increase profits in the long-term. In some circumstances, the short-term investment of \$20,000 to \$60,000 is too high of a barrier despite the potential future profitability through revitalized and enhanced space.

Some local business owners have requested the City assist with additional grant funding for such improvements. The use of ARPA funds could be considered for that purpose. The funds are time-limited (must be under contract by December 31, 2024) and are ideal for one-time expenses such as a pilot program. A drafted grant program, structurally similar to the Small Business Economic Development Grant, is attached for the Commission to review and provide further guidance to staff.

Business Improvement and Expansion Grant (ARPA Pilot Program)

Purpose: The purpose of the grant is to provide financial assistance to help overcome the potentially prohibitive costs for adding fire suppression and accessibility improvements to existing buildings.

Background: In recent years, City staff have encountered two common scenarios when working with local building owners. The first is that someone will purchase an existing building with a vision for the type of business that will occur there without conducting due diligence on what renovations or updates will be needed to accommodate those plans. This leads to frustration with the City when they learn of safety requirements that may include high cost items such as sprinklers (fire suppression) or interior ADA-compliant changes like additional restrooms. These are also somewhat technical areas and may require an engineer or architect to develop plans for such updates (an additional cost).

The second common scenario is that a local business plans to utilize vacant space in their existing building and learns of the required updates for safety and accessibility. Many local buildings, especially in the historic downtown, were not constructed with modern requirements in mind. However, the City is responsible for applying not only international building codes for existing buildings but also for ensuring a common sense approach for public safety to mitigate dangerous circumstances.

Goals:

- Provide financial assistance to help overcome the initial high cost of fire suppression and ADA accessible improvements
- Encourage better utilization of existing business spaces
- Increase the quality of available business spaces to draw new business to Leavenworth
- Lower building insurance premiums

Criteria:

- \$200,000 ARPA funding available on a first-come, first-serve basis until funds are expended
- 50% of eligible expenses up to \$30,000 (on a \$60,000 project)
- Citywide, existing retail and commercial buildings (Zoned business district)
- Must directly support a current or identified business (not speculative)
- For improvements made or under contract to be performed between November 1, 2022 and December 30, 2024 (Mandatory ARPA timeframe)
- Improvements made before November 1, 2022 are not eligible (the grant is not retroactive)
- Eligible improvements will remain with the property to support a future business should the building be sold or re-purposed:
 - o Engineer/architect plan development expenses
 - Leavenworth Waterworks main connection fees
 - Installation and supply costs from a licensed contractor
- Can utilize the Small Business Economic Development Grant (if eligible) or the Business Improvement and Expansion Grant (not both for the same expenses)
- Completed application and contractor's quote for work required
